SUBJECT: Decision on DSCTA Certifications for Comm 10 and Speech 30 Equivalency

DATE : 28 October 2022

On April 4 and October 3, the Department of Speech Communication and Theater Arts (DSCTA) issued certifications stating that COMM 10 *Critical Perspectives in Communication* and Speech 30 *Public Speaking and Persuasion* are equivalent GE courses. (Please see attached.) These certifications were issued directly to offices without going through the GEC, thus prompting several personnel and students to clarify their equivalence. The GEC deemed it proper to investigate and convene the UPD GE Committee to discuss the issue. On its October 21 meeting, the UPD GE Committee requested the DSCTA to narrate the process which led to the issuance of the certifications. Upon receipt of DSCTA's letter, the UPD GE Committee met on October 28 to resolve the matter. The results of our discussion are the following resolutions:

- That the UPD GE Committee upholds DSCTA's decision in its October 25 letter that COMM 10 and Speech 30 are two different courses, reversing its earlier certifications (dated April 4 and October 3).
- 2. That the DSCTA admits that the issuance of the two earlier certifications dated April 4 and October 3, which state that "Comm 3, Comm 10, and other similar courses may be credited as Speech 30 under the new curriculum," is a result of human error. Upon thorough discussion, the DSCTA concluded that "there are more differences than similarities between Comm 10 and Speech 30."
- 3. That we maintain the status quo of Speech 30 as a required GE course and COMM 10 as another GE course that may be taken by students.
- 4. That the students affected by the April 4 and October 3 certifications until the current semester (1st semester, AY 2022-2023) will not be made to bear the burden of the error; graduating students in the current semester (1st semester, AY 2022-2023) are advised to reach out to their respective SREs for prompt evaluation.
- 5. That these certifications **cannot and shall not be applied starting** next semester (2nd semester, AY 2022-2023). Students who are not yet graduating in the 1st semester, AY 2022-2023 must still take Speech 30 as a required GE course in UPD, even if they have taken COMM 10 in other CUs.
